

## TERMS AND CONDITIONS

### Tour 2014 Locker Cleanout

#### Entry

1. Manchester United Limited ("**MU**") (whose registered office is Old Trafford, Sir Matt Busby Way, Manchester M16 0RA) is the promoter of Manchester United's Tour 2014 Locker Cleanout prize draw (the "**Prize Draw**").
2. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
3. Entry into the Prize Draw is free and on the basis of one entry per person.
4. In order to be automatically entered into the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw through the "Competition" Facebook application or via the Tour 2014 online form located at <http://www.manutd.com/Tour2014>.
5. The Prize Draw will close at 23:59 on 15 August 2014 (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.
6. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.

#### Prize

7. Subject to paragraph 8, the prize will consist of items of Manchester United playing kit and/or training kit worn by the Manchester United first team squad players during Manchester United's 2014 pre-season tour of the United States of America signed by at least one member of the Manchester United playing staff or coaching staff (together the "**Prize**"). MU gives no guarantee that any part of the Prize will be signed by a particular player. MU will not enter into any correspondence as to which MU players any part of the Prize will be signed by.
8. MU reserves the right to substitute any part of the Prize with another of a similar nature at any time.
9. The Prize is non-transferable and there is no cash alternative.

#### Winner

10. The winner will be selected at random from all valid entries received on or before the Closing Date (the "**Winner**").
11. Only the Winner of the Prize Draw will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the Winner.
12. The Winner (or the Winner's parent or guardian if the Winner is under 16 years of age) will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes.

13. If MU cannot successfully contact the Winner within within one week of that Winner being drawn (having made reasonable efforts), or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner (or the parent or guardian of the Winner if the Winner is under 16 years of age) does not provide the consent requested at paragraph 12 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
14. Subject to paragraphs 12 and 13 above, details of the Winner will be made available to the public upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

#### **General**

15. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
16. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
