

TERMS AND CONDITIONS
#ThisIsYourTurf – Global Prize Draw

Entry

1. Manchester United Limited (“**MU**”) is the promoter of the #ThisIsYourTurf prize draw (the “**Prize Draw**”).
2. To enter the Prize Draw, participants must complete the relevant data entry fields (including the country to which they wish any Prize (as defined in Paragraph 7) to be delivered) for the Prize Draw through the #ThisIsYourTurf section of the MU website (the “**Website**”) or the #ThisIsYourTurf Facebook app (the “**App**”).
3. Entry to the Prize Draw is on the basis of one entry per person, however entrants will receive one additional ‘bonus’ entry into the Prize Draw for each social network which they use to share the Prize Draw from those which can be selected via the tool on the Website or the or the App. Those social networks will be Facebook, Twitter and Google+.
4. The closing date for entries to the Prize Draw is 10:00 UK time on 30 September 2013 (“**Closing Date**”) and all entries received after the Closing Date shall not be entered into the Prize Draw.
5. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions (“**Conditions**”) and confirms that all information submitted is true, current and complete. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements.
6. The Prize Draw is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

7. The Prize Draw prizes will be one of 100 pieces of turf taken from locations on the pitch at Old Trafford stadium. 25 pieces of turf will be taken from a location on the Old Trafford pitch where an iconic MU-related football moment has taken place (“**Main Prizes**”). The remaining 75 pieces of turf will be taken from any location on the Old Trafford pitch (“**Runner-up Prizes**”).
8. Please note that certain countries impose restrictions which prevent the importation of plants or seeds and therefore MU is not able to send Main Prizes or Runner-up Prizes to certain countries. These countries include (but are not limited to) Vietnam, Japan and Australia. Winners or Runners-up (as defined in Paragraph 9) will not be sent Main Prizes or Runner-up Prizes if they live in a country which has restrictions which prevent the importation of the Main Prizes or the Runner-up Prizes. If a Winner or Runner-up is resident in a country which has restrictions preventing the sending of turf to that country, that Winner or Runner-up will receive an MU first team football shirt signed by members of the MU first team squad (“**Alternative Prizes**”) in place of a Main Prize or a Runner-up Prize (the Main Prizes, the Runner-up Prizes and the Alternative Prizes together, the “**Prizes**”).
9. The winners of the Prize Draw will be selected as soon as reasonably practicable after the Closing Date. Subject to Paragraph 10, the winners of the Main Prizes will be the first 25 names selected at random from all entries who have fulfilled the requirements in Paragraphs 2 and 3 by the Closing Date (each a “**Winner**” and together the “**Winners**”). The winners of the Runner-up Prizes will be the next 75 names selected at random from all entries who have fulfilled the requirements in Paragraphs 2 and 3 by the Closing Date (each a “**Runner-up**” and together the “**Runners-up**”).
10. Notwithstanding Paragraph 9, MU may, in its sole discretion, elect that one Winner and/or one Runner-up will selected from any particular territory. In such instance, the

Winner and Runner-up for any such territory will be the first and second names selected at random from all entries who have fulfilled the requirements in Paragraphs 2 and 3 by the Closing Date and who have indicated the relevant territory in accordance with Paragraph 1. The number of names selected in accordance with Paragraph 9 will be reduced by the number of names selected in accordance with this Paragraph 10. For the avoidance of doubt, there will be no limit to the number of territories MU may elect pursuant to this Paragraph 10.

11. MU will use reasonable care to ensure that the Main Prizes are taken from locations as close as possible to where the relevant iconic MU football moment took place. However, MU makes no guarantee of the accuracy of such location and/or that any Main Prize has been taken from the precise location or is within a certain distance of where the relevant iconic moment took place.
12. The specific iconic MU moment allocated to a winner will be at MU's absolute discretion. MU will not enter into any correspondence with Winners regarding which Main Prize each Winner will receive.
13. The members of the MU first team squad who sign the Alternative Prizes will be at MU's absolute discretion and MU gives no guarantee that any Alternative Prize will be signed by a particular player. MU will not enter into any correspondence as to which MU players any Alternative Prize will be signed by.
14. Only the Winners and the Runners-up shall receive notification from MU. The Winners and the Runners-up will be notified by email as soon as practicable after the Closing Date and will be asked to confirm their postal address. Any Winner or Runner-up who does not reply to MU's initial email within one week of it being sent by MU will be disqualified from the Prize Draw and a new Winner or Runner-up will be drawn. Following the draw, the Prizes will be sent by courier to each Winner and each Runner-up.
15. Any ancillary costs and expenses associated with the Prizes, such as subsistence, accommodation and travel, will not be provided by MU and shall be borne by the Winners or the Runners-up. The Prizes are non-transferable and no cash alternative is available.
16. MU makes no guarantee that any Prize will be delivered to any Winner or Runner-up. Save for the initial sending of the Prizes by courier to the address provided by each Winner or Runner-up upon entering the Prize Draw, neither MU nor DHL (the courier company) will be liable for: (i) any fees, fines or any other costs associated with the sending and delivery of the Prizes; or (ii) any cost associated with re-sending any Prize. No Winner or Runner-up will be entitled to claim a further Prize in the event that any Prize is not delivered. Entry to the Prize Draw is subject to DHL's Terms and Conditions of Carriage set out at www.dhl.co.uk.
17. MU makes no guarantee as to the longevity or appearance of the turf forming the Main Prizes and the Runner-up Prizes. MU will not be liable for any damage to any Main Prize or Runner-up Prize in transit or any degradation in the appearance of any Main Prize or Runner-up Prize over any time period whatsoever.
18. The Winners and Runners-up (and their guardians if under 16) will be required to give their consent to the following: (i) for the Winner's or Runner-up's name to be disclosed to any person requesting that MU confirm the identity of a Winner or a Runner Up; and (ii) for the Winner's or Runner-up's name and/or photograph to be published for promotional purposes.
19. If any Winner or Runner-up, drawn at random, is unable or unwilling to: (i) accept a Prize; or (ii) provide the consent requested at paragraph 17 above, subsequent draws will take place until a new winner is found who is able/willing to accept the relevant Prize and provide the necessary consent.

20. Subject to paragraphs 18 and 19 above, details of the Winners and the Runners-up will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the Closing Date (subject to data protection legislation).
21. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
22. The Prize Draw, together with these Conditions, is governed by the laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
