

TERMS AND CONDITIONS

“Find Fred” Prize Draw

Entry

1. Manchester United Limited (“**MU**”) is the promoter of this prize draw (“**Prize Draw**”).
2. Entry to the Prize Draw is on the basis of one entry per person and is subject to the entry requirements detailed at Paragraph 3 below.
3. To enter the Prize Draw, participants must complete the relevant data entry fields and take part in the “Find Fred” game at the web address findfred.manutd.com.
4. Entries must be received by 23:59 hours GMT on 31 January 2013 (the “**Closing Date**”). For the avoidance of doubt, any entries received after the Closing Date will not be entered into the Prize Draw.
5. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions (“**Conditions**”) and confirms that all information submitted is true, current and complete. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
6. The Prize Draw is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

7. The Prizes for the Prize Draw are as follows:
 - (i) an official Manchester United replica shirt signed by members of the Manchester United first team squad (“**1st Prize**”);
 - (ii) a Red Café Post-Match Package for two people (one of whom must be over 18 years of age as at the date of the match attended) at a Premier Match of the winner’s choice (“**2nd Prize**”);
 - (iii) an official Manchester United football signed by members of the Manchester United first team squad (“**3rd Prize**”); or
 - (iv) one of five Manchester United Memberships for the 2013-14 English Premier League season (“**4th Prize**”) (together the “**Prizes**”).
8. A “**Red Café Post-Match Package**” means a hospitality package at the Red Café (situated in the Old Trafford stadium) following a Manchester United home game which will usually include the following features (subject to availability and any changes made at MU’s sole discretion): Manchester United Legend Q&A; Sir Alex Ferguson Stand match day ticket; champagne on arrival; three-course meal; matchday programme and gift; 10% discount merchandise voucher; and stadium car parking for one car.
9. A “**Premier Match**” means a Manchester United home match in the English Premier League in the 18 months following the Closing Date against any team with the exception of matches against the following opponents: Arsenal, Chelsea, Liverpool and Manchester City.

Winners

10. The Prize Draw will take place as soon as reasonably practicable after the Closing Date.
11. A total of eight winners will be selected at random from all of the eligible entries received on or before the Closing Date.
12. The Prizes shall be allocated to the winners based on the order that they are selected and in accordance with the order that the Prizes are set out in Paragraph 7. For example, the first individual selected as a winner in accordance with Paragraph 10 will receive 1st Prize, the second individual selected 2nd Prize, the third individual selected 3rd Prize and the next five individuals selected 4th Prize.
13. Only winners shall receive notification from MU. Winners will be notified by email as soon as practicable after the Closing Date. Following the draw the Prizes will be posted to the winners.
14. The Prizes are non-transferable and no cash alternative is available.
15. The MU Matchday VIP terms and conditions in force at the time 2nd Prize is redeemed will also apply to the use of 2nd Prize. MU reserves the right to amend the MU Matchday VIP terms and conditions for the 2013/14 season.
16. Each winner of the Prize Draw (and his/her guardian if under 16) will be required to give their consent to the following: (i) for the winner's name to be disclosed to any person requesting that MU confirm the identity of the Prize Draw winners; and (ii) for the winner's name and/or photograph to be published by MU for promotional purposes.
17. If any winner, drawn at random, is unable or unwilling to: (i) accept the prize allocated; or (ii) provide the consent requested at Paragraph 16 above; subsequent draws will take place until a winner is found who is able/willing to accept the prize allocated and provide the necessary consent.
18. Subject to Paragraphs 16 and 17 above, details of the Prize Draw winners will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the Closing Date (subject to data protection legislation).

20. The Prize Draw, together with these Conditions, is governed by the laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
