Competition terms and conditions

Entry

1. Manchester United Limited (“**Manchester United**”) is the promoter of the prize draw (the “**Prize Draw**”).
2. Entry to the Prize Draw is on the basis of one entry per person, and in order to enter, participants must correctly answer the question posed and submit their entries by midday on Thursday 31 March 2011 (the “**Closing Date**”).
3. By entering the Prize Draw the participant agrees to be bound by these terms and conditions (“**Conditions**”) and confirms that all information submitted is true, current, accurate and complete.
4. The draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

Prize

5. The winner will be the first participant chosen at random from all of the eligible entries received on or before the Closing Date.
6. Only the winner shall receive notification from Manchester United. The winner will be notified by telephone as soon as practicable after the Closing Date and by no later than 7 April 2011. Following the draw, the prize will be posted to the winner at the address stated on the entry form. Manchester United is not liable for the acts or omissions of any postal service provider. If Manchester United cannot contact a winner within 24 hours of that winner being drawn (making reasonable efforts), then that winner forfeits the right to any prize and another entrant will be drawn for that prize.

7. The decision of Manchester United is final and no correspondence will be entered into.
8. The prize is a Manchester United football signed by one member of the first team squad. The cost of postage of the prize to the winner shall be borne by Manchester United.
9. The prize is non-transferable and no cash alternative is available. If a winner is unable or unwilling to accept the prize or does not provide the consent requested at Condition 10 below, subsequent draws will take place until a new winner is found who is able/willing to accept the prize and provide the necessary consent.

The winners (and their guardians if under 16) will be required to give their consent to the following: (i) for the winners' names to be disclosed to any person requesting that Manchester United confirm the identity of the prize winners; and (ii) for the winners' names and/or photographs to be published for promotional purposes.
