

## **Terms and Conditions Aviva Stadium Prize Draw**

### **Entry**

1. Manchester United Limited ("**MU**") is the promoter of the Aviva Stadium prize draw (the "**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter, participants must be over the age of 18, have correctly answered the Prize Draw question and filled out all fields on the Aviva Stadium Prize Draw form. The form must have been submitted before 17:00 on 3 September 2010.
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete.
4. The draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

### **Prize**

5. The winners will be selected at random on 6 September 2010 from all correct entries received by the date set out at Paragraph 2 (the "**Winners**").
6. Only the Winners shall receive notification from MU. The Winners will be notified either by email, telephone and/or in writing as soon as is practicable after 9 September 2010. If MU cannot successfully contact the Winners within 48 hours of that Winner being drawn (making reasonable efforts), then that Winner forfeits the right to the Prize and another entrant will be drawn for the Prize.
7. The decision of MU is final and no correspondence will be entered into.
8. The prize for the Prize Draw will be a hospitality package for two persons (any minors must be accompanied by an adult over the age of 18) to attend the football match between Manchester United and Liverpool Football Club on Sunday 19 September 2010 (the "**Prize**").
9. Ancillary costs and expenses associated with the Prize, such as travel, accommodation and subsistence, will not be provided by MU and shall be borne by the Winners.
10. The Prize is non-transferable and there is no cash alternative. MU reserves the right to substitute any Prize with another of a similar nature and/or equal or greater value at any time. If the Winner is unable or unwilling to accept the Prize, or does not provide the consent required at paragraph 11 below, subsequent draws will take place until a new Winner is found who is able/willing to accept the Prize or provide the necessary consent.
11. By entering the Prize Draw, the Winner consents to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirm the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional or marketing purposes.

13. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
14. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English Courts.
