

TERMS AND CONDITIONS

Facebook Season Ticket Competition

Entry

1. Manchester United Limited ("**MU**") is the promoter of this prize draw ("**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and participants who meet the entry requirements detailed at paragraph 3 below will be automatically entered into the Prize Draw.
3. To enter the Prize Draw, each participant must: (i) click on the relevant link on the MU Facebook page; (ii) after clicking on the link and being taken to www.manutd.com, click the "Enter Competition" button; (iii) after clicking on the Enter Competition button, when prompted to do so either login (if already registered) or register as a registered user on www.manutd.com; and (iv) correctly answer the question displayed following login or registration.
4. Entries must be received by 19 August 2012 (the "**Closing Date**"). For the avoidance of doubt, any entries received after the Closing Date will not be entered into the Prize Draw.
5. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
6. The Prize Draw is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

7. The winner of the Prize Draw will receive a Manchester United season ticket for all home matches in the Barclays Premier League for the 2012/13 football season (the "**Prize**"). Please note, the Prize does not include tickets for any Manchester United home cup match which the winner of the Prize must purchase pursuant to the Season Ticket Terms and Conditions 2012/13.
8. The location of the season ticket within the stadium will be at MU's discretion.
9. The Prize Draw will take place as soon as reasonably practicable after the Closing Date. The winner will be the first name to be selected at random from all of the eligible entries received on or before the Closing Date.
10. Only the winner shall receive notification from MU. The winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the Prize will be posted to the winner.
11. Any ancillary costs and expenses associated with the Prizes, such as subsistence, accommodation and travel, will not be provided by MU and shall be borne by the winner. The Prize is non-transferable and no cash alternative is available.
12. The Prize winner (and a guardian if under 16) will be required to give their consent to the following: (i) for the winner's name to be disclosed to any person requesting that MU confirm the identity of a Prize winner; and (ii) for the winner's name and/or photograph to be published by MU for promotional purposes.

13. If any winner, drawn at random, is unable or unwilling to: (i) accept the Prize; or (ii) provide the consent requested at paragraph 12 above, subsequent draws will take place until a new winner is found who is able/willing to accept the Prize and provide the necessary consent.
