

One United Members Competition - Terms and Conditions (Email Prize Draw)

Entry

1. Manchester United Limited (“**MU**”) is the promoter of the One United Members Prize Draw (“**Competition**”).
2. All entrants to the Competition must be between the ages of 12-15 years of age and physically able to take part in pitch activities.
3. Employees of MU (and the employees’ families) or any of its associated companies or subsidiaries are not eligible to enter the Competition.
4. Entry to the Competition is on the basis of one entry per person and entry shall be automatic when the entrant agrees to, and subsequently provides, his/her name, age, address, contact telephone number, One United Membership Number and a brief explanation of why he/she should win the Prize (as defined below), via email to membershipcompetition@manutd.co.uk.
5. By entering the Competition the entrant agrees to be bound by these terms and conditions (“**Conditions**”) and confirms that all information submitted is true, current and complete. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy eligibility requirements.
6. Entries will not be accepted after midnight on Sunday 20th December 2009.

Prize

7. Four winners will be selected from all eligible entries received pursuant to clause 4 (the “**Winners**”).
8. Only the Winners shall receive notification from MU. The Winners will be notified by telephone on the contact telephone number provided under clause 4, on Monday 21st December 2009.
9. If MU cannot successfully contact the Winners within a reasonable length of time (using the contact telephone number provided) it may, in its sole discretion, select another name at random.
10. The decision of MU is final and no correspondence will be entered into.
11. The prize for the competition is the opportunity to be invited to take part in a “Trickster” competition at half time during the football match between Manchester United Football Club and Wigan Athletic Football Club on Wednesday 30th December 2009 at Old Trafford, as well as receiving a two complimentary tickets to the game, one for the Winner and another for an accompanying adult (each of the four Prizes being referred to as the “**Prize**”).
12. Ancillary costs and expenses associated with the Prize, such as subsistence, will not be provided by MU and shall be borne by the Winners.
13. The Prize is non-transferable and there is no cash alternative. MU reserves the right to substitute the Prize with another of a similar nature and/or equal or greater value at any time.

General

14. By entering the Competition, the Winners consent to the following: (i) for the Winners’ names to be disclosed to any person requesting that MU confirm the identity of the Winners; and (ii) for the Winners’ names and/or photographs to be published for promotional or marketing purposes.
15. MU reserves the right to cancel or amend the Competition or these Conditions without notice in the event of circumstances beyond its reasonable control.
16. The Competition, together with these Conditions, is governed by the laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
