

Terms and Conditions

Manchester United Limited Prize Draw

Entry

1. Manchester United Limited is the promoter ("**Promoter**") of the Predict the Score prize draw (the "**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter, participants must be over the age of 18 and have entered the Prize Draw in accordance with the instructions of the respective hospitality suite by: (i) submitting a text with the correctly predicted match score to the number 07786 209447 (text messages will be charged at the usual network rate); or (ii) submitting the paper entry form provided to them to the relevant member of staff, before kick off on the day of the respective match.
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**").
4. The draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

Prize

5. The winners will be selected at random following full time after each respective match, from all entries received in accordance with Paragraph 2 (the "**Winners**"). Only one Winner will be drawn per match.
6. Only the Winners shall receive notification from the Promoter. The Winners will be notified either by email, telephone and/or in writing as soon as is practicable after the respective Winner has been drawn. If the Promoter cannot successfully contact the Winners within 48 hours of that Winner being drawn (making reasonable efforts), then that Winner forfeits the right to the Prize and another entrant will be drawn for the Prize.
7. The decision of the Promoter is final and no correspondence will be entered into.
8. The prize for the Prize Draw will be one Manchester United football shirt signed by at least one Manchester United first team player (each a "**Prize**" and together, the "**Prizes**"). The respective Prize will be sent to the Winner by post within 14 days of the Winner being contacted.
9. The Prizes are non-transferable and there are no cash alternatives. The Promoter reserves the right to substitute any Prize with another of a similar nature and/or equal or greater value at any time. If the Winner is unable or unwilling to accept a Prize, or does not provide the consent required at paragraph 11 below, subsequent draws will take place until a new Winner is found who is able/willing to accept the Prize or provide the necessary consent.
10. By entering the Prize Draw, the Winners consent to the following: (i) for the Winners' names to be disclosed to any person requesting that the Promoter confirm the identity of the Winners; and (ii) for the Winners' name and/or photograph to be published for promotional or marketing purposes.

12. The Promoter reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.

13. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English Courts.
