

Terms and Conditions

Manchester United Waiting List Prize Draw

1. Manchester United Limited and Manchester United Football Club Limited ("**Manchester United**") are the promoters of the prize draw ("**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter, participants must be over the age of 18 and have filled out all fields on the Manchester United Prize Draw form available at www.manutd.com/default.sps?pageid={B4CEE8FA-9A47-47BC-B069-3F7A2F35DB70}&newsid=6617466 before 23:59 on 6 August 2010.
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete.
4. The draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

Prize

5. The winners will be selected at random on 9 August 2010 from all entries received by the date set out at Paragraph 2 (the "**Winners**").
6. Only the Winners shall receive notification from Manchester United. The Winners will be notified either by email, telephone and/or in writing as soon as is practicable after 9 August 2010. If Manchester United cannot successfully contact the Winners within 48 hours of that Winner being drawn (making reasonable efforts), then that Winner forfeits the right to the Prize and another entrant will be drawn for the Prize.
7. The decision of Manchester United is final and no correspondence will be entered into.
8. The prize for the Prize Draw will be one of two Matchday VIP packages for a Winner and a guest to Manchester United vs Newcastle United on 16 August 2010, in a hospitality suite to be decided by Manchester United, (each a "**Prize**" and together the "**Prizes**").
9. Ancillary costs and expenses associated with the Prizes, such as travel, accommodation and subsistence, will not be provided by Manchester United and shall be borne by the Winners.
10. The Prizes are non-transferable and there are no cash alternatives. Manchester United reserves the right to substitute any Prize with another of a similar nature and/or equal or greater value at any time. If a Winner is unable or unwilling to accept a Prize, or does not provide the consent required at paragraph 11 below, subsequent draws will take place until a new Winner is found who is able/willing to accept the Prize or provide the necessary consent.

By entering the Prize Draw, the Winners consent to the following: (i) for the Winners' names to be disclosed to any person requesting that Manchester United confirms the identity of the Winners; and (ii) for the Winners' name and/or photograph to be published for promotional or marketing purposes.
