

TERMS AND CONDITIONS

Mid-Season Mailer - Membership Prize Draw

Entry

1. Manchester United Limited ("**MU**") is the promoter of this prize draw ("**Prize Draw**").
2. Entry to the Prize Draw is only available to individuals who hold a valid Manchester United membership ("**Members**") and is subject to the entry requirements detailed at paragraph 3 below.
3. Entry into the Prize Draw is dependent upon a Member referring an individual to purchase a discounted Manchester United Membership. A Member will refer an individual by: (i) providing that individual with their unique Manchester United membership number; and (ii) that individual quoting the Member's membership number to purchase a discounted Manchester United membership. Upon an individual's purchase of a discounted Manchester United membership, the Member whose membership number was quoted will be automatically entered into the Prize Draw. A Member will receive one entry per referral and there is no limit to the amount of referrals that any one Member may make.
4. Only purchases of discounted memberships made before 23.59 GMT on 1 February 2013 (the "**Closing Date**") will result in the referring Member being entered into the Prize Draw. For the avoidance of doubt, any purchases made after the Closing Date will not result in the referring Member being entered into the Prize Draw.
5. By referring an individual the Member accepts that if that individual purchases a discounted membership by quoting the Member's details they will be entered into the Prize Draw and be bound by these terms and conditions ("**Conditions**"). The referring Member confirms that they hold a valid Manchester United membership. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
6. The Prize Draw is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

7. The Prizes for the Prize Draw are as follows:
 - (i) a Matchday VIP Package (as determined by MU) for two people (one of whom must be over 18 years of age as at the date of the match attended) at a Premier Match of the winner's choice ("**1st Prize**");
 - (ii) an official Manchester United replica shirt signed by members of the Manchester United first team squad ("**2nd Prize**"); and
 - (iii) an official Manchester United football signed by members of the Manchester United first team squad ("**3rd Prize**") (together the "**Prizes**").
8. A "**Premier Match**" means a Manchester United home match in the English Premier League in the 18 months following the Closing Date against any team with the exception of matches against the following opponents: Arsenal, Chelsea, Liverpool and Manchester City.

Winners

9. The Prize Draw will take place as soon as reasonably practicable after the Closing Date.

10. A total of three winners will be selected at random from all of the eligible entries received on or before the Closing Date.
11. The Prizes shall be allocated to the winners based on the order that they are selected and in accordance with the order that the Prizes are set out in Paragraph 7. For example, the first individual selected as a winner in accordance with Paragraph 10 will receive 1st Prize, the second individual selected 2nd Prize and the third individual selected 3rd Prize.
12. Only the winners shall receive notification from MU. Each winner will be notified by email as soon as practicable after the Closing Date. Following the draw the Prizes will be posted to the winners.
13. The Prizes are non-transferable and no cash alternative is available.
14. The MU Matchday VIP terms and conditions in force at the time 1st Prize is redeemed will also apply to the use of 1st Prize. MU reserves the right to amend the MU Matchday VIP terms and conditions for the 2013/14 season.
15. Each winner of the Prize Draw (and his/her guardian if under 16) will be required to give their consent to the following: (i) for the winner's name to be disclosed to any person requesting that MU confirm the identity of the Prize Draw winner; and (ii) for the winner's name and/or photograph to be published by MU for promotional purposes.
16. If any winner, drawn at random, is unable or unwilling to: (i) accept the Prize; or (ii) provide the consent requested at paragraph 15 above; subsequent draws will take place until a winner is found who is able/willing to accept the Prize and provide the necessary consent.
17. Subject to paragraphs 15 and 16 above, details of the Prize Draw winners will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the Closing Date (subject to data protection legislation).
18. MU reserves the right to cancel or amend the Competition or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
19. The Competition, together with these Conditions, is governed by the laws of England and shall be subject to the exclusive jurisdiction of the English Courts.
