

TERMS AND CONDITIONS

Membership Newsletter Competition

Entry

1. Manchester United Football Club Limited ("**MU**") is the promoter of this competition ("**Competition**"). The Competition will run from during each concurrent football season (usually from August to 31 May each year) unless and until cancelled by MU at any time at its sole discretion.
2. In advance of each issue of the Official Manchester United Members' Newsletter ("**Newsletter**"), MU will hold a prize draw ("**Prize Draw**") giving current Official Manchester United Members ("**Members**") the chance to win a prize designated by MU. All Members as at the date of each Prize Draw will be automatically entered into the relevant Prize Draw.
3. In consideration for entry into the Competition, Members agree to be bound by these terms and conditions ("**Conditions**") and shall at all times act in good faith towards MU and the Competition.
4. The Competition is not open to: (i) employees of MU (or its associated companies or subsidiaries) or their families; and (ii) any individual who is not a current Member.

Prize

5. Each Prize Draw will take place in advance of publication of the Newsletter to which it relates. The winner will be the first name to be selected at random from all of the eligible Members as at the date of the Prize Draw. Only the winner shall receive notification from MU, with such notification to take place as soon as reasonably practicable after the Prize Draw and in advance of publication of the Newsletter to which the Prize Draw relates.
6. The winner of each Prize Draw will receive a prize to be chosen at MU's discretion (the "**Prize**"). The details of each Prize will be included in the relevant newsletter.

8. The Prize winner (and a guardian if under 16) will be required to give their consent to the following: (i) for the winner's name and (if applicable) photograph to be published in the relevant edition of the Newsletter; (ii) for the winner's name to be disclosed to any person requesting that MU confirm the identity of a Prize winner; and (iii) for the winner's name and/or photograph to be published for promotional purposes.
9. Any ancillary costs and expenses associated with the Prize, such as subsistence, accommodation and travel, will not be provided by MU and shall be borne by the winner. The Prize is non-transferable and no cash alternative is available.
10. If any winner, drawn at random, is unable or unwilling to: (i) accept the Prize; or (ii) provide the consent requested at paragraph 8 above, subsequent draws will take place until a new winner is found who is able/willing to accept the Prize and provide the necessary consent.
11. Subject to paragraphs 8 and 10 above, details of each Prize Draw winner will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the publication of the relevant Newsletter (subject to data protection legislation).
