

## Terms and Conditions

### Official Membership November Ticket & Shirt Competition

#### Entry

1. Manchester United Limited ("**MU**") is the promoter of Manchester United's Official Membership November Ticket & Shirt Competition prize draw (the "**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and in order to enter participants must:  
(i) login to the members only One United area of ManUtd.com; (ii) correctly answer the question located at [http://www.manutd.com/One-United/Login.aspx?redirectPath=/en/Fanzone/Competition-And\\_Polls/Competition.aspx?id={5CA6D5A1-E115-412F-BFC7-BB69EBA84A96}&regmode=full](http://www.manutd.com/One-United/Login.aspx?redirectPath=/en/Fanzone/Competition-And_Polls/Competition.aspx?id={5CA6D5A1-E115-412F-BFC7-BB69EBA84A96}&regmode=full); and (iii) submit their entries before midnight on 28 November 2011 (any entries received after this date will not be eligible).
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**").
4. The Prize Draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

#### Prizes

5. One winner ("**Winner**") and one runner up ("**Runner Up**") will be selected at random from all of the eligible entries submitted on or before midnight on 28 November 2011.
6. The prize for the Winner will be four tickets to the Manchester United v Blackburn Rovers match on 31 December 2011, the location of such tickets to be determined by MU ("**First Prize**"). The Winner of the First Prize may choose to receive either: (i) two adult tickets and two child tickets; or (ii) one adult ticket and three child tickets.
7. The prize for the Runner Up will be a Manchester United shirt signed by at least one member of the MU first team squad ("**Second Prize**").
8. Only the Winner and the Runner Up will receive notification from MU. The Winner and the Runner Up will be notified by MU by email, telephone or post on or around Thursday 1 December 2011.
9. Both the First Prize and Second Prize are non-transferable and there is no cash alternative. MU reserves the right to substitute any part of the First Prize and/or Second Prize with another of a similar nature and/or equal or greater value at any time. If the Winner or Runner Up is unable or unwilling to accept their prize, or does not provide the consent required at paragraph 13 below, subsequent draws will take place until a new Winner or Runner Up is found who is able/willing to accept the relevant prize and provide the necessary consent.
10. The decision of MU is final and no correspondence will be entered into.
11. If the Winner is under the age of 18 they must be accompanied by a parent or guardian who is over the age of 18.
12. The First Prize and Second Prize do not include any travel, accommodation, food or other arrangements.

#### General

13. By entering the Prize Draw, the Winner and Runner Up consent to the following: (i) for their names to be disclosed to any person requesting that MU confirm the identity of the Winner and/or the Runner Up; and (ii) for MU to use their names and addresses, their photographs and audio and/or visual recordings of them for promotional or marketing purposes.

15. MU will use any personal information submitted by the entrants in accordance with data protection legislation and the privacy preferences (if any) specified by the entrant during entry to the Prize Draw.
16. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
17. To the maximum extent permitted by law, MU shall not be liable for any damage, loss, injury or disappointment suffered by any entrant entering the Prize Draw or as a result of any Winner or Runner Up accepting or taking part in the prizes. Nothing shall exclude MU's liability for death or personal injury as a result of its negligence.
18. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English Courts.
