

## **Terms and Conditions**

### **Paul Scholes Signed Shirt Competition**

#### **Entry**

1. Manchester United Limited ("**MU**") is the promoter of Manchester United's Paul Scholes signed shirt prize draw (the "**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and shall be in the form of an automatic entry when the entrant submits their details via the designated form in the Paul Scholes section of MU's official website ([www.manutd.com](http://www.manutd.com)). All Prize Draw entries must be submitted by midnight on 8 August 2011.
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete.
4. The Prize Draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

#### **Prize**

5. The prize for the Prize Draw will be an MU shirt signed by Paul Scholes (the "**Prize**").
6. The Prize is non-transferable and there is no cash alternative. MU reserves the right to substitute the Prize or any part of it with another of a similar nature and/or equal or greater value at any time.
7. The winner will be selected at random from all entries received in accordance with these Conditions (the "**Winner**") and will be notified by email on or before 15 August 2011.
8. Only the Winner shall receive notification from MU. If MU cannot successfully contact the Winner within one week of that Winner being drawn (having made reasonable efforts), then that Winner forfeits the right to the Prize and another entrant will be drawn for the Prize. If the Winner is unable or unwilling to accept the Prize, or does not provide the consent required at paragraph 11 below, subsequent draws will take place until new Winners are found who are able/willing to accept the Prize or provide the necessary consent.
9. The Prize will be sent to the Winner by 7 September 2011, subject to any delays beyond the control of MU including but not limited to any delay caused by any Winner/s not being contacted in accordance with paragraph 8 above.
10. The decision of MU is final and no correspondence will be entered into.
11. By entering the Prize Draw, all entrants (and their parent/s or guardian if the entrant is under 16 years of age) consent to the following in the event that they are drawn as the Winner: (i) for their name to be disclosed to any person requesting that MU confirm the identity of the Winner; and (ii) for their name and/or photographs to be published for promotional or marketing purposes.

13. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
14. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English Courts.
