

TERMS AND CONDITIONS

Season Ticket Renewal Competition

Entry

1. Manchester United Limited and Manchester United Football Club Limited (together "**MU**") are the promoters of this prize draw ("**Prize Draw**").
2. To enter the Prize Draw, each participant must: (i) have held a season ticket at Manchester United Football Club during the 2011/12 football season; and (ii) have renewed their season ticket for the 2012/13 football season before 5pm on 1 June 2012 (the "**Closing Date**").
3. Entry to the Prize Draw is on the basis of one entry per season ticket. Participants who meet the entry requirements detailed at paragraph 2 above will be automatically entered into the Prize Draw. **If you do not wish to be entered into the prize draw you should notify Manchester United at Old Trafford, Sir Matt Busby Way, Manchester, M16 0RA.**
4. For the avoidance of doubt, any season ticket holders who renew their season tickets after the Closing Date will not be entered into the Prize Draw.
5. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
6. The Prize Draw is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

7. There are three prizes available for the winners of the Prize Draw:
 - (i) a trip for two to watch a Manchester United game on the Manchester United 2012 Summer Tour (the "**First Prize**");
 - (ii) the winner to have his/her 2012/12 season ticket paid for (the "**Second Prize**"); and
 - (iii) a signed Manchester United home shirt (the "**Third Prize**").
8. The Prize Draw will take place as soon as reasonably practicable after the Closing Date and in any event by no later than 13 June 2012. The winners will be the first three names to be selected at random from all of the eligible entries received on or before the Closing Date.
9. Only the winners shall receive notification from MU. The winners will be notified by email as soon as practicable after the monthly closing date. Following the draw, the applicable prize will then be posted to each winner.
10. The First Prize will consist of a trip for two people to watch a single football match on the Manchester United 2012 Summer Tour (the "**Tour Match**"), with the identity of the Tour Match to be determined by MU in its absolute discretion. The First Prize will include two tickets for the Tour Match, flights and transfers for two people to and from the location of the Tour Match, and hotel accommodation for two people for a number of nights to be determined by MU in its absolute discretion. All other ancillary costs

and expenses associated with the First Prize, such as subsistence and spending money, will not be provided by MU and shall be borne by the winner of the First Prize.

11. If the winner of the First Prize is under 16, they must be accompanied by an adult guardian on the trip to watch the Tour Match.
12. The winner of the Second Prize will have his/her 2012/13 season ticket paid for by MU and any sums already paid by the winner in respect of the same will be refunded. MU will pay for the cost of the season ticket and all home cup games. For the avoidance of doubt, the foregoing will only apply to the season ticket that the winner of the Second Prize had applied to renew. It will not be open to the winner of the Second Prize to nominate a season ticket to be paid for by MU.
13. The winner of the Third Prize will receive a 2012/13 Manchester United home team shirt signed by at least one of the current Manchester United first team squad. The signor will be chosen by MU in its absolute discretion and no correspondence will be entered into.
14. Unless specifically outlined above, any ancillary costs and expenses associated with any of the prizes, such as subsistence, accommodation and travel, will not be provided by MU and shall be borne by the winner. All prizes are non-transferable and no cash alternatives are available.
15. All prize winners must agree to attend the Old Trafford football stadium in advance of a home game at the start of the 2012/13 season, where each winner will be announced to the Old Trafford Crowd and have their photograph taken.
16. All prize winners (and a guardian if under 16) will also be required to give their consent to the following: (i) for the winner's name to be disclosed to any person requesting that MU confirm the identity of a prize winner; and (ii) for the winner's name and/or photograph to be published for promotional purposes.
17. If any winner, drawn at random, is unable or unwilling to: (i) accept the prize; (ii) attend Old Trafford as required by paragraph 15 above; or (iii) provide the consent requested at paragraph 16 above, subsequent draws will take place until a new winner is found who is able/willing to accept the prize and provide the necessary consent.
18. Subject to paragraphs 15, 16 and 17 above, details of each Prize Draw winner will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the closing date (subject to data protection legislation).
19. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
20. The Prize Draw, together with these Conditions, is governed by the laws on England and shall be subject to the exclusive jurisdiction of the English Courts.
