

TERMS AND CONDITIONS
#thisisyourturf Moments of Greatness Competition

Entry

1. Manchester United Limited ("**MU**") is the promoter of the #thisisyourturf moments of greatness competition (the "**Competition**").
2. Entry to the Competition is on the basis of one entry per video submitted. In order to enter, participants must make a video recording of themselves recreating an MU-related iconic football moment and upload it to Twitter using the hashtags #OTmoment and #thisisyourturf.
3. The closing date for entries to the Competition is 30 September 2013 (the "**Closing Date**") and all entries received after the Closing Date shall not be entered into the Competition.
4. By entering the Competition entrants agree to be bound by these terms and conditions (the "**Conditions**") and confirm that all information submitted is true, current and complete and that any entries are their own original work. MU reserves the right to verify the eligibility of all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants agree that MU has the right to show any video entries on any media, including but not limited to Twitter and the MU website.
5. The Competition is not open to employees of MU (or its associated companies or subsidiaries) or their families.

Prize

6. The Competition prize will be a piece of turf taken from the pitch at Old Trafford stadium (the "**Prize**").
7. Following the Closing Date, representatives of MU will select the five best videos of all eligible videos received on or before the Closing Date. From the five videos selected, one or more MU players or former players will select the winning video. The winner of the Competition will be the entrant responsible for the submission of the winning video as selected by the judges (the "**Winner**"). The runners up of the competition will be the entrants responsible for the submission of the four remaining videos (the "**Runners Up**").
8. The decisions of MU and the judges of the Competition are final and no correspondence will be entered into. The players or former players selected by MU to act as the judges will be at MU's absolute discretion and no correspondence will be entered into.
9. Only the Winner and the Runners Up shall receive notification from MU. The Winner and the Runners Up shall be announced via MU's website at manutd.com as soon as practicable after the Closing Date. The Prize will then be posted to the Winner. Only one Prize will be awarded to the Winner, regardless of how many people participate in the making of or appear in the winning video.
10. Please note that certain countries impose restrictions which prevent the importation of plants or seeds and therefore MU is not able to send the Prize to certain countries. These countries include (but are not limited to) Vietnam, Japan and Australia. The Prize will not be sent to any Winner resident in a country which has restrictions preventing the importation of the Prize. Any such Winner will receive an MU first team football shirt signed by members of the MU first team squad (the "**Alternative Prize**") in place of the Prize.

11. The members of the MU first team squad who sign the Alternative Prize (if applicable) will be at MU's absolute discretion and MU gives no guarantee that the Alternative Prize will be signed by a particular player. MU will not enter into any correspondence with the Winner as to which MU players the Alternative Prize will be signed by.
12. Any ancillary costs and expenses associated with the Prize will not be provided by MU and shall be borne by the Winner. The Prize is non-transferable and no cash alternative is available.
13. MU makes no guarantee that the Prize will be delivered to the Winner. Save for the initial sending of the Prize by courier to the address provided by the Winner, neither MU nor DHL (the courier company) will be liable for: (i) any fees, fines or any other costs associated with the sending and delivery of the Prize; or (ii) any costs associated with re-sending the Prize. The Winner will not be entitled to claim a further or replacement Prize in the event that the Prize is not delivered. Entry to the Promotion is subject to DHL's Terms and Conditions of Carriage set out at www.dhl.co.uk.
14. MU makes no guarantee as to the longevity or appearance of the turf forming the Prize. MU will not be liable for any damage to the Prize in transit or any degradation in the appearance of the Prize over any time period whatsoever.
15. The Prize is non-transferable and no cash alternative is available. If the Winner is unable or unwilling to accept the Prize, does not provide the consent requested at paragraph 16 below, a new Winner will be selected from the remaining Runners Up who is able and willing to accept the Prize and provide the necessary consent.
16. The Winner and the Runners Up (and their guardians if under 16) will be required to give their consent to the following: (i) for the names of the Winner and the Runners Up to be disclosed to any person requesting that MU confirm the identity of the Winner or the Runners Up; and (ii) for the names and/or photographs of the Winner and the Runners Up to be published for promotional purposes.
17. Subject to paragraphs 15 and 16 above, details of the Winner and the Runners Up will be made available upon request from Manchester United Limited, Sir Matt Busby Way, Old Trafford, Manchester, M16 0RA two weeks after the closing date (subject to data protection legislation).
18. MU reserves the right to cancel or amend the Competition or these Conditions without notice in the event of the occurrence of circumstances beyond its reasonable control.
19. The Competition, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
