

## TOUR TREASURE VAULTS 2013 - TERMS & CONDITIONS

Thank you for your interest in ManUtd.com's Tour Treasure Vaults 2013 - the prize draw which gives you the chance to win a treasure vault containing player-signed souvenirs from United's travels to Thailand, Australia, Japan, Hong Kong and Sweden.

### Entry

1. Manchester United Limited ("**MU**") is the promoter of Manchester United's Tour Treasure Vault prize draw (the "**Prize Draw**").
2. Entry to the Prize Draw is on the basis of one entry per person and entry shall be automatic when the entrant submits their details via the Tour 2013 online form or via the Facebook Tour Treasure Vaults app on Facebook.
3. By entering the Prize Draw the entrant agrees to be bound by these terms and conditions ("**Conditions**") and confirms that all information submitted is true, current and complete.
4. The closing date for entries to the Prize Draw is 23:59 on 6 August 2013 (the "**Closing Date**") and all entries received after the Closing Date shall not be entered into the Prize Draw.
5. The Prize Draw is not open to employees of Manchester United (or its associated companies or subsidiaries), or their families.

### Prize

6. The Winners will be the first five names selected at random as soon as practicable after the Closing Date from all entries received in accordance with these Conditions (each a "**Winner**" and together the "**Winners**").
7. Only the Winners shall receive notification from MU. The Winners will be notified by email within one week of selection. If MU cannot contact any Winner within one week of that Winner being drawn (having made reasonable efforts), then that Winner forfeits the right to the Prize and another Winner will be drawn.
8. The prizes for the Prize Draw will be five cases (one for each Winner), each containing items from one of Thailand, Australia, Japan, Hong Kong and Sweden collected during the 2013 Manchester United pre-season tour (each a "**Prize**" and together the "**Prizes**"). Each item in each case will have been signed by at least one member of the Manchester United playing staff or coaching staff. The MU players who sign the Prizes will be at MU's absolute discretion. MU gives no guarantee that any Prize will be signed by a particular MU Player. MU will not enter into any correspondence as to which MU players any Prize will be signed by.
9. The Prizes will be drawn in no particular order and each Winner will be awarded one Prize at random. MU gives no guarantee that any Prize relating to any particular country of the tour will be awarded to any one Winner. MU will not enter into any correspondence as to which Prize will be awarded to any Winner.
10. The Prizes are non-transferable and there is no cash alternative. MU reserves the right to substitute any part of the Prizes with another of a similar nature and/or equal or greater value at any time. If any Winner is unable or unwilling to accept the Prizes, or does not provide the consent required at paragraph 11 below, subsequent draws will take place until a new Winner are found who are able/willing to accept the Prize or provide the necessary consent.
12. By entering the Prize Draw, the Winner's (and their parent or guardian if the entrant is under 16 years of age) consent to the following: (i) for the Winners' names to be disclosed to any person requesting that MU confirm the identity of the Winners; and (ii) for the Winners' names and/or photographs to be published for promotional or marketing purposes.
