

TERMS AND CONDITIONS

United for UNICEF Gala Dinner Tickets 2018 Prize Draw

Entry

1. Manchester United Football Club Limited ("**MU**") (whose registered office is at Old Trafford, Sir Matt Busby Way, Manchester M16 0RA (the "**Stadium**")) is the promoter of the United for UNICEF Gala Dinner Tickets 2018 prize draw (the "**Prize Draw**").
2. By entering the Prize Draw entrants agree to be bound by these terms and conditions ("**Conditions**") and confirm that all information submitted is true, accurate and complete. MU reserves the right to verify the eligibility of any and all entrants and may, in its sole discretion, disqualify any entrant that fails to satisfy the eligibility requirements. Entrants shall at all times act in good faith towards MU and the Prize Draw.
3. Employees of MU or any of its associated companies or subsidiaries (and their families) are excluded from entering the Prize Draw.
4. The Prize Draw is open to entrants aged 18 years or over who are a resident in the United Kingdom at the date of entry.
5. Entry into the Prize Draw is free (except for any applicable data usage charges) and on the basis of one entry per person.
6. In order to enter the Prize Draw and to be considered for the Prize, entrants must complete the relevant data entry fields for the Prize Draw:
 - i. in the overlay form available on the "Enquire Online" link at <http://www.unitedevents-manutd.com/>;
 - ii. through the link accessible via the individual email sent to the entrants personal email address; or
 - iii. via any other method of entry which MU makes available.
7. The Prize Draw will close at 23:59 GMT on Saturday 1 December 2018 (the "**Closing Date**") and any entries received after the Closing Date will not be entered into the Prize Draw. The Prize Draw will take place as soon as reasonably practicable following the Closing Date.

Prize

8. Subject to paragraph 10, the prize will consist of two (one for the Winner and one for their guest) complimentary tickets to the United for UNICEF Gala Dinner 2018 which will be held at the Stadium on a date to be determined and announced by MU at MU's absolute discretion (or any other rearranged date) (the "**Event**"), which might include food and/or beverages (MU reserves the right to determine the extent to which any food and/or beverages will be provided free of charge) but does not include any travel, accommodation or any other associated costs (the "**Prize**"). Any ancillary costs and expenses associated with the Prize, such as subsistence, will not be provided by MU and must be borne by the Winner.
9. Entry to The United for UNICEF Gala Dinner 2018 event may be subject to any terms and conditions which MU provide.
10. MU reserves the right to substitute the Prize with another of a similar nature at any time.
11. The Prize is non-transferable and there is no cash alternative.

Winner

12. The winner will be the first person selected at random from all valid entries received on or before the Closing Date (the "**Winner**"). The Winner will receive the Prize.
13. Only the Winner will receive notification from MU. The Winner will be notified by email as soon as practicable after the Closing Date. Following the draw, the tickets for the Prize will be made available for collection by the Winner at MU's premises. The Winner and the Winner's guest must be aged 18 years or over.
14. The Winner will be required to give their consent to the following: (i) for the Winner's name to be disclosed to any person requesting that MU confirms the identity of the Winner; and (ii) for the Winner's name and/or photograph to be published for promotional purposes, although the Winner may raise any concerns regarding this paragraph 14 with MU.
15. If MU cannot successfully contact the Winner within a reasonable length of time, or if the Winner is unable or unwilling to accept the Prize, or if the Winner does not meet the eligibility requirements, or if the Winner does not provide the consent requested at paragraph 14 above, subsequent draws will take place until a new winner is found who is able, willing and eligible to accept the Prize and provide the necessary consents. This new winner shall be deemed to be the Winner for the purposes of these Conditions.
16. Subject to paragraphs 14 and 15 above, details of the Winner will be made available to the public upon request from Manchester United Football Club Limited, Sir Matt Busby Way, Old Trafford, Manchester M16 0RA two weeks after the Closing Date (subject to data protection legislation).

General

17. MU reserves the right to cancel or amend the Prize Draw or these Conditions without notice when reasonably necessary for the purpose of administering the Prize Draw.
18. The Winner and the Winner's guest must comply with the required dress code for the Event.
19. MU reserves the right (in its absolute discretion) to:
 - i. refuse to admit the Winner and/or the Winner's guest to the Stadium;
or
 - ii. eject the Winner and/or the Winner's guest from the Stadiumfor example, where:
 - a) the admission and/or presence of the Winner and/or the Winner's guest may cause a nuisance to other guests at the Event;
 - b) where MU considers that the presence of the Winner and/or the Winner's guest may lead to the damage, destruction or loss of property; or
 - c) the Winner and/or the Winner's guest fail(s) to observe the dress code for the Event.
20. The Prize Draw, together with these Conditions, is governed by the laws of England and Wales and shall be subject to the exclusive jurisdiction of the English courts.
